Public debt according to national legislation (the GEO no 64/2007) includes:

- public government debt representing indebtedness incurred directly or guaranteed by the Romanian Government through MoPF, including the amounts advanced temporarily from the State Treasury accounts and debt contracted by the line ministries.
- local public debt representing indebtedness incurred directly or guaranteed by the local administration unit.

Government debt according to EU methodology, means total gross debt at nominal value outstanding at the end of the year and consolidated at general government subsectors level.

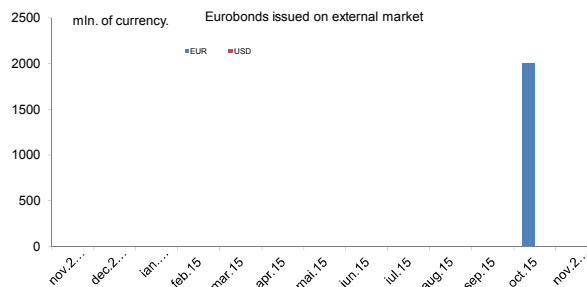

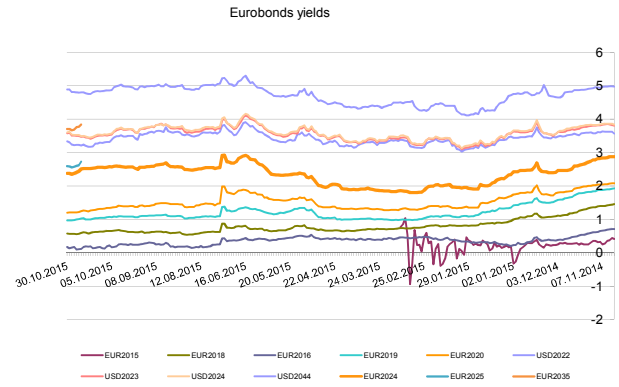

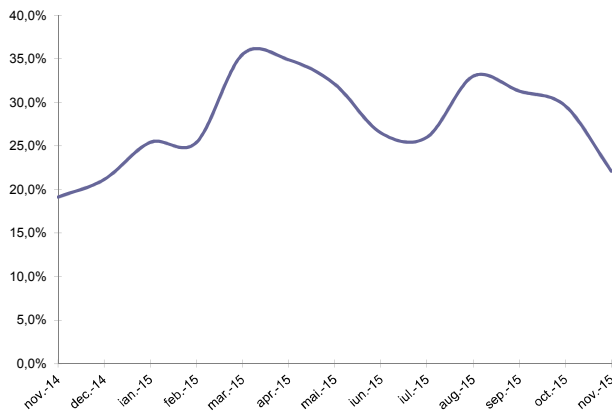
Government securities issued between January 1, - November 30, 2015



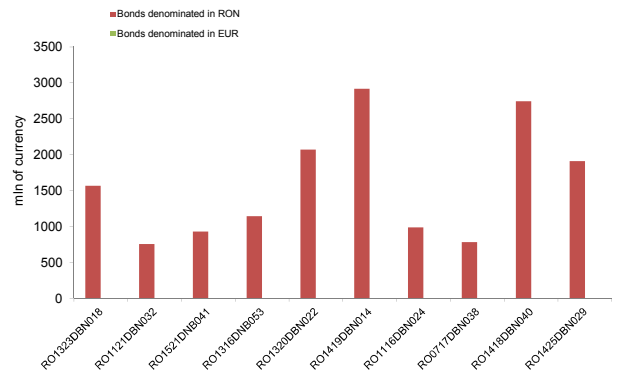
2. Secondary market of government securities

The most tradable government securities issued on domestic market in November 2015



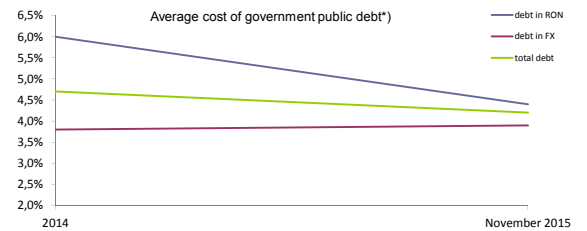

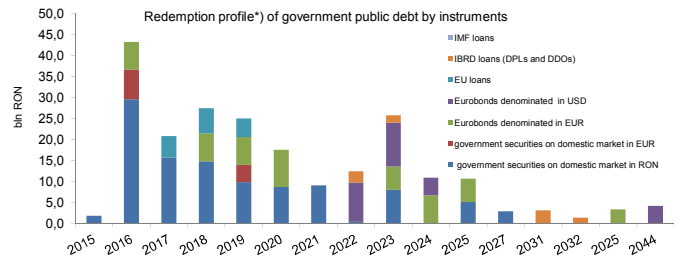
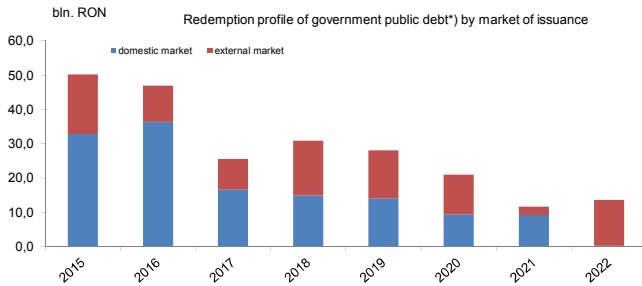
V. Implementation of DMS 2015-2017

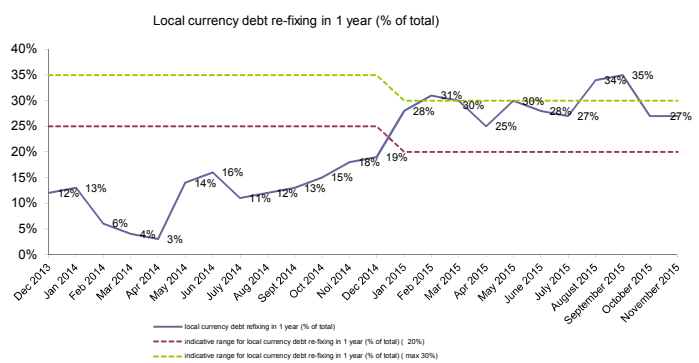
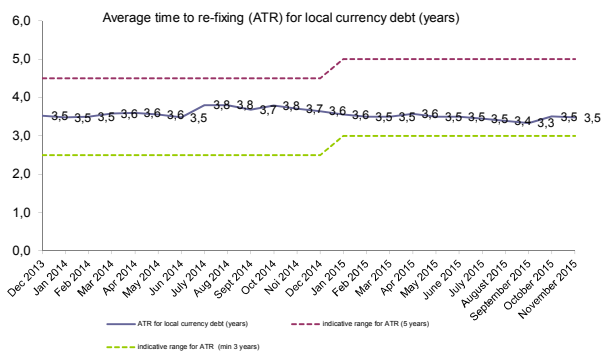
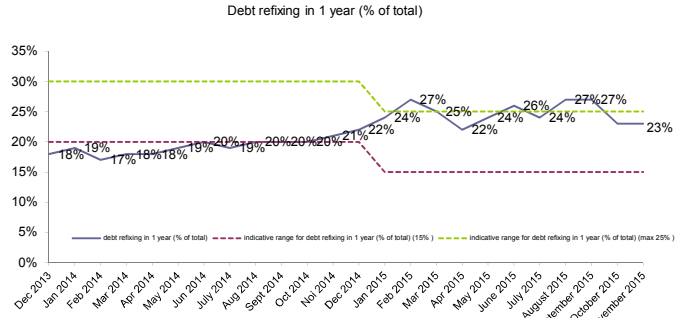
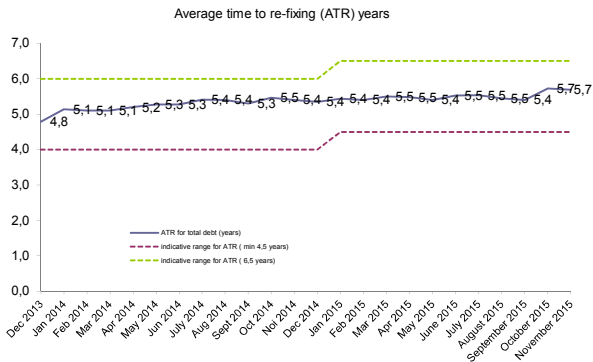
2. Refinancing risk

3. Interest rate risk



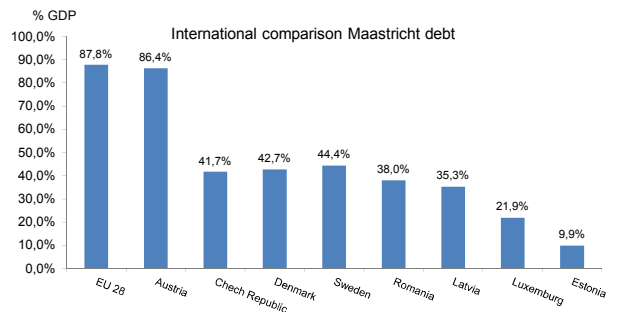
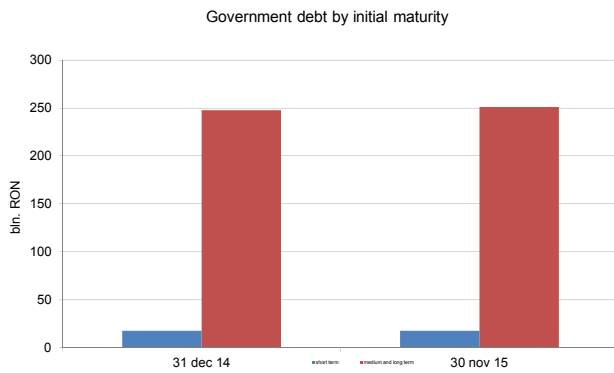
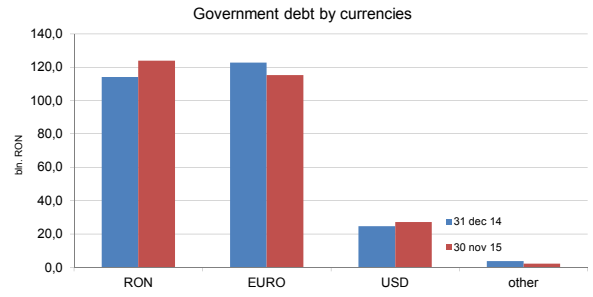
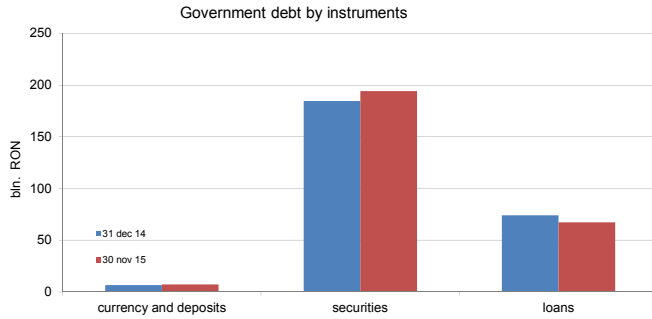

At the end of Q3, 2015 government debt represented 37,2% of GDP, well below the level registered in the EU-28 (86% of GDP), and the Euro Zone (81,6% of GDP).
